

**Coach driver information:** there is a dedicated coach park in the lower car park. **Visiting groups must be kept on the bus until our Education Co-ordinator arrives.**

The Education Co-ordinator will escort the group to a safe area so that the coach can then park or leave.

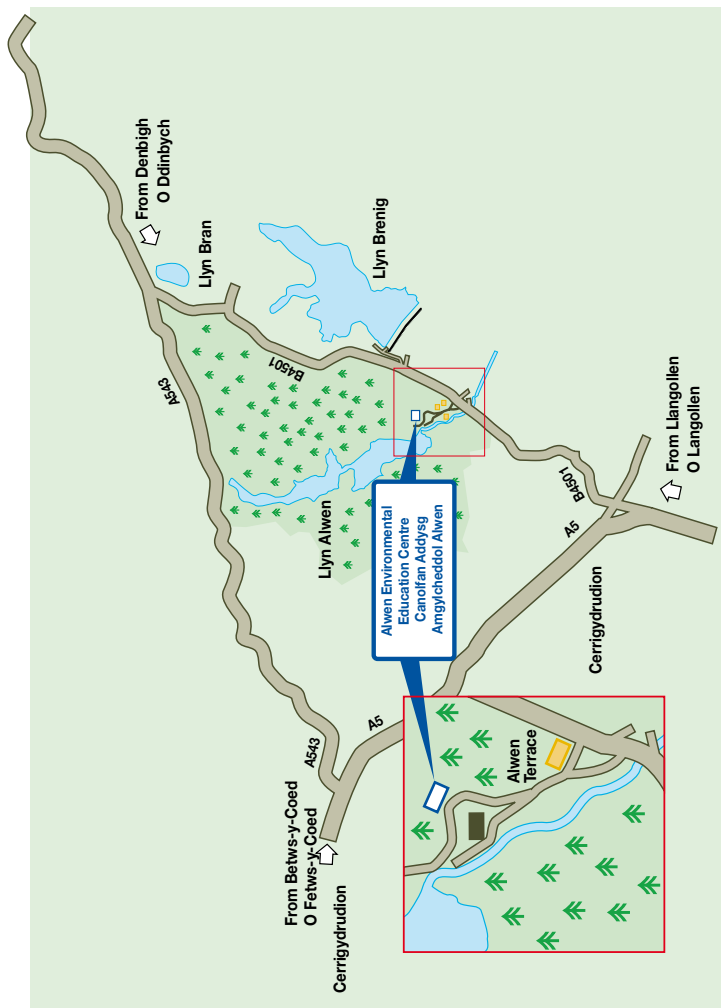
The coach and driver are more than welcome to stay on site but we must insist that the bus driver does not walk around the site, other than to the classroom to use the welfare facilities.

## Health and Safety Iechyd a Diogelwch

*Information for educational visits*

Thank you for choosing Alwen Environmental Education Centre for your school visit. Educational visits play a crucial role in the curriculum so we want you to have a safe and enjoyable visit. Please read the following Health and Safety information to ensure your day goes smoothly.

Prior to your visit please inform us of any children with SEN, medical or behavioural problems. This includes pupils with 1:1 support for any part of the day. **It is imperative that their support member of staff accompanies them throughout the visit to our site.**

Unfortunately, if this is not possible, we cannot allow them to visit.

**Visiting groups should be a maximum of 35 pupils with a ratio of 1 adult to 7 children.** Children should be split into 4 groups (of approx. 7 children) before arriving on site and an adult helper allocated to each group. Please note that our required supervision ratios may differ from your LEA.

**No children under the age of 6 are allowed on site.**

**The day begins at 10am and finishes at 2.30pm.**

During the day all visitors will need:

- ◆ A packed lunch.
- ◆ Outdoor clothing.
- ◆ Suitable outdoor footwear.

**Alwen is an operational site so it is important that, for their safety, children are kept on the bus until our teacher arrives.**

All parties must stay on designated pathways at all times unless instructed otherwise by one of our staff.

**Visiting staff are responsible for:**

- ◆ The conduct of all party members including adult helpers who must be briefed on our Health and Safety guidelines before the visit.
- ◆ Provision of first aid kits.
- ◆ Administration of first aid to any party members.
- ◆ The supervision of all party members during lunch.

**All of our activities are fully risked assessed, copies of the risk assessments are available on request.**

Be aware that the river study and kick activities may have to be changed at short notice depending on the weather, pond studies will be offered as an alternative.

**Please ensure you have a complete class list with you on the day of the visit for fire evacuation purposes.**

*If there is an operational problem on site, there may be cause to cancel your visit at short notice.*

Gofynnir i chi ddarllen y wybodaeth a ganlyn am lechyd a Diogelwch er mwyn sicrhau bod eich ymweliad yn rhedeg yn esmwyth.

Cyn eich ymweliad, rhowch wybod i ni os oes gennych blant ag AAA, problemau meddygol neu broblemau ymddygiad. Mae hyn yn cynnwys plant sy'n cael cymorth 1:1 am unrhyw ran o'r diwrnod. **Mae'n rhaid i'r aelod o'r staff sy'n eu cynorthwyo fod gyda nhw trwy gydol yr ymweliad â'n safle ni.** Gwaetha'r modd, os nad yw hyn yn bosibl, ni allwn ganiatáu iddynt ymweld â ni.

**Ni ddylai fod mwy na 35 o ddisgyblion mewn grŵp, gydag un oedolyn i bob 7 plentyn.** Dylid rhannu'r plant i bedwar grŵp (o tua 7 plentyn) cyn cyrraedd y safle a threfnu bod oedolyn yn helpu pob grŵp. Sylwch: Efallai bod ein ffigurau goruchwylio ni yn wahanol i rai eich AALI chi.

**Ni chaniateir dod â phlant o dan 6 oed ar y safle.**

**Mae'r diwrnod yn dechrau am 10am ac yn gorffen am 2.30pm.**

Bydd ar bob ymwelydd angen

- ◆ Pecyn cinio.
- ◆ Dillad awyr agored.
- ◆ Esgidiau addas ar gyfer bod y tu allan.

**Mae canolfan Alwen yn safle gwaith ac felly mae'n bwysig, er eu diogelwch, bod y plant yn cael eu cadw ar y bws hyd nes y daw ein hathro.**

Rhaid i bawb aros ar y llwybrau a nodwyd bob amser os nad oes un o'n staff yn dweud fel arall wrthynt.

**Cynhelir asesiad risg i'n holl weithgareddau. Holwch os hoffech gofio'u o'r asesiadau risg.**

Cofiwch y gall fod angen newid ein gweithgareddau astudio neu gicio afon ar fyr rybudd yn dibynnu ar y tywydd. Cynigir gweithgareddau astudio'r pwll yn lle hynny.

**Gofalwch fod gennych restr gyflawn o'r disgyblion gyda chi ar y diwrnod rhag ofn y bydd angen gadael y safle oherwydd tân.**
